### Sharon Reeder Retires

Sharon Reeder has retired from her job working for Watsonville Airport, effective December 31, 2008. To all that knew her there--she will be missed.

My acquaintance with her began when she first came to work here in about 1983. So she has worked at KWVI for 25 years.

She came from Fremont Airport and my recollection was that she flew a Cessna 140 there. Bob Ross, United Flight Services, told me that he had a hangar at Fremont, did some maintenance there and was acquainted with Sharon . He said she worked as Assistant Airport Manager. She did the usual, almost everything, fueling, taking tie-down fees, and other airport jobs. That was in the early 1980s.

Her friendly demeanor and positive attitude impressed me from the start. Most of our many enjoyable visits occurred when she refueled the jet I flew for Granite Construction Company. I was always glad to see her when I called for fuel for my Cherokee 180 or Mooney. At all times she was just plain helpful. She was always interested in the well-being and viability of Watsonville Airport.

I talked to Vern Ackerman, past Airport Manager, who hired her. His comment: "Sharon was one of my very best employees, honest, trustworthy, reliable, hard working, -- everybody liked her."

My suspicion is that one of her biggest job challenges was in October 1989, after the Loma Prieta Earthquake caused so much damage; including closing almost all access highways and roads in this area. The airport was the life-line of Santa Cruz County, when thousands of emergency flights brought medical supplies, food, clothing, and emergency workers here. Sharon managed the airport operations efficiently, smoothly and effectively. These kind of complimentary articles sound like "throwing flowers around" – well, with Sharon that's easy -- it reflects who she is. Dan Chauvet

# LOOKING TO BECOME A SPORT PILOT?

Whether you've had a medical reason to let your medical expire or are looking for a pilot certificate that doesn't require a flight physical, check out the sport pilot certificate. Already certificated pilots need no additional training to switch to sport pilot. It allows you to carry one other passenger onboard the aircraft. Just switch to a new market of aircraft--called light sport aircraft--and follow the regulations for the sport pilot certificate. Some familiar airplanes, like the Piper J-3 Cub and Aeronca Champ, are considered light sport aircraft. You don't need to have a current medical, just a driver's license. # AOPA asks FAA to suspend rulemaking for Luke Airspace

In formal comments filed Dec. 15 with the FAA, AOPA asked the agency to suspend the current rulemaking process until more information can be gathered about the need for and impact of proposed special air traffic rules around Luke Air Force Base.

The Air Force wants to create a special air traffic rule (SATR) to help separate civilian and military aircraft in the congested airspace near Arizona's Luke Air Force Base. But AOPA contends that the military has not produced recent evidence demonstrating the need for the airspace and that the airspace, as designed, could create new safety problems for general aviation aircraft transiting the Phoenix area.

The Air Force is basing its request on near midair collision data from before 2000. But that information is outdated and does not account for the voluntary efforts by AOPA, local airports, and the Air Force to reduce the problem—efforts begun in 2000.

In addition, the proposal could create new hazards by crowding VFR traffic into narrow corridors at low altitudes in order to avoid the special-use airspace, and it does not account for how that might affect pilots and people on the ground, AOPA argued.

## HISTORY OF WATSONVILLE AIRPORT

Dale Skillicorn is writing a history of Watsonville Airport and is seeking funding for the project. This will be a valuable addition to the history of Watsonville as well the history of aviation in Santa Cruz County. His purpose is to document the value and necessity of Watsonville Airport as an emergency transportation facility, a supporter of business and jobs, an educational asset and career starter, a historical institution, and irreplaceable regional transportation resource.

He proposes to donate net sales proceeds to a local aviation scholarship program and the Pajaro Valley Historical Association. The plan is to publish 200 to 250 copies and have them available at the Watsonville Fly-In and other events locally. Dale estimates that the total costs will be about \$5000 and breaks down the costs as follows: Printing & Bindery: \$1,500: Graphics including photo layouts: \$400 - \$700: Photographs: \$300 - \$500:
