### **Demurrer Denied**

The attorneys for the City of Watsonville filed a demurrer to exclude the State Division of Aeronautics from the legal action, WPA VS the City. The dictionary says a demurrer is an objection; and law-wise "is a pleading [by the City] in effect that even if the facts are as alleged by the opposite party [WPA and CALTRANS], they do not sustain the contention based on them." On Thursday January 4 the judge denied the demurrer. He stated that the Division of Aeronautics will not be excluded, and indicated that what the City is planning is unsafe. That has to be considered a big plus for the Watsonville Pilots Association and others involved.

Reportedly the city attorneys appeared to be disappointed. The question arises, will the City continue the costly action to try to ram through the bad airport land use planning contained in the new General Plan 2030 and the made-to-fit EIR.

The basic problem is that the cost of installing all the infrastructure, such as water, sewer, and roads, requires that a future specific plan contain at least the 2250 houses, in order to be economically feasible. A high percentage of these houses will be in "Buena Vista I" which is aligned with Runway 26, the second-most-used runway (existing houses now exceeds the maximum in runway safety zones 1 through 4). This density of development is incompatible with legitimate, responsible airport land use planning. Pilots must have options if they have to make a forced landing. People should not be subjected to the risk of an aircraft crashing into their homes. The City has not come up with a Specific Plan for Buena Vista.. Attorneys say that a faulty General Plan paves the way for a faulty Specific Plan. Any Specific Plan, based on General Plan 2030, will not provide for the health, safety and welfare of the people traveling by air or those on the ground. Airport supporters would be gullible and naïve to expect that the City's future Specific Plan would come close to being safe. It will create a permanent noise and safety problem. The lessons of history show that encroachment is often the demise of runways and airports and leads to more lawsuits.

The demurrer decision provides for the inclusion of the Division of Aeronautics in the effort to ensure responsible airport land use planning around Watsonville Airport. That's good news for everybody who is interested keeping airports viable and safe. ~ Dan Chauvet ~

# Back to the future at Castle Airport New Class D and control tower opening

If you haven't read the Federal Register recently (just kidding—does anyone read that?), you may have missed that Castle Airport in Atwater, CA, the home of the fourth longest runway on the West coast, is getting a control tower again. Of course, it used to have a control tower years ago when it was home to a SAC base and dozens of our nation's B-52 bombers. The bombers are gone and Castle was relatively quiet for many years. However a large flight school moved there last year, increasing the number of operations, and there's also a need to protect IFR operations into the airport. So effective January 18, 2007, you'll want to plan to use the following frequencies:

Unicom/ Gemini Flight Support...... 123.075 There's one odd note in the Federal Register, which reads "This action would establish Class D airspace extending upward from the surface to 2,500 feet Mean Sea Level (MSL) within a 4.5 nautical mile radius of the airport." Of course a standard class D has a fourmile radius. For some reason--perhaps the two mile long runways-this new Class D is <u>larger</u> than standard.

There are all kinds of reasons to go to Castle. The best of course is to view the many historic military aircraft at Castle Air Museum. Their collection has some rare birds including the SR-71 Blackbird, the fastest flying aircraft in the world today, an F-4 Thunderbird, a RB-36 Peacemaker, a B-24 Liberator. If you've never seen a Peacemaker—one flew over Jimmy Stewart in the movie Strategic Air Command—it's quite a sight with six propeller engines behind the wind of this massive bomber in a pusher configuration. You may also want to hold your next business conference or fly-in at Castle. If you choose to stay over and be billeted, according to their website, "You will be staying in what was formerly known as the TLQ's (Transient Living Quarters), where all rooms remain intact with Air Force furniture, the very same that was used when this was an active base."

### National group targets Watsonville control near airport

WATSONVILLE; A national aviation group is pushing for state legislation that would force Santa Cruz County to establish a commission to oversee development proposals near the Watsonville Municipal Airport.

The action is the latest in a series of legal and political challenges designed to influence the city's plans to expand north of the airport in the Buena Vista Road area.

In the next two decades hundreds of homes, as well as shopping centers, schools and parks, could be built in the area on what is now agricultural land and open space.

The proposal by the Maryland-based Aircraft Owners and Pilots Association aims to end Santa Cruz's exemption to a 40-year-old California law requiring countywide airport land-use commissions, and would shift a measure of control over development decisions away from Watsonville leaders.

"From our perspective, this is a public safety issue. Essentially poor land-use planning in the short term creates unnecessary safety problems in the future," said Chris Dancy, spokesman for the national group.

Local pilots and airport backers have lobbied for a commission because they believe Watsonville's leaders ignored the potential for increased safety and noise problems when making their plans. Historically, county and regional groups with say over Watsonville's development have favored more limited growth than city leaders.

Santa Cruz County is exempt from law, in part, because Watsonville owns the airport.

Three other rural counties, Alpine, Modoc and Sierra, also are exempt because their leaders made an official finding that no landuse conflicts exist.

Dancy said his group, which has more than 400,000 members nationwide and 50,000 in California, hasn't lined up a legislator to carry the bill, but is talking to several potential sponsors.

The effort has city officials worried enough that Mayor Manuel Bersamin sent a letter to Assemblyman John Laird, D-Santa Cruz, late last month asking him to oppose any attempt to introduce such legislation.

City Manager Carlos Palacios said he'd like to find a middle ground, such as establishing a city commission to advise on airport issues.

"We are concerned about it," Palacios said Monday. "It would take some of the land-use decisions out of City Council's hands and put it in a county committee. That's another layer of government we'd have to go to, another layer of bureaucracy. It would be advisory ... but it adds another complication"

#### **Icing Effect on Aircraft**

Rayvon Williams gave another excellent Wings presentation on Icing Effect on Aircraft. He started with an icing video and referenced a NASA web site for a course on icing. It can be found at: http://aircrafticing.grc.nasa.gov/courses.html Some highlights of the presentation were:

- Always have a plan or a way out.
- $\triangleright$ Although icing won't immediately make the plane fall out of the sky, do immediately plan to get out of it.
- $\triangleright$ The temperature rang where icing occurs most frequently is between  $+2^{\circ}c$  and  $-20^{\circ}c$ .
- The highest moisture is normally found at the top of the clouds. Large drops can be below freezing temperature and still be a
- liquid. This is known as supercooled. Helpful tips: Turn off the Autopilot. Use maximum prop RPM.
